

MAL047 - Gnien iz-Zghir

Description

Ġnien iż-Żgħir is a semi-artificial reservoir, intended for irrigation and water storage, located in western Malta between Had-Dingli and Rabat. The reservoir covers an area of approximately 1,420m2. A limestone wall has been constructed around the border in order to increase the reservoir's water storage capacity. The site is surrounded by agricultural fields and has numerous pipelines within the reservoirs, indicating that it is used for irrigation. The site is not protected by any legislation.
